Course Materials: The majority of class readings and assignments will be taken from Judith Areen and Marc Spindelman Family Law casebook, 7th edition. Any additional reading materials will be posted on the class Twen page either under "Additional Reading Materials" (pdfs of most newspaper articles are here) or "web links" or they are available through Westlaw. These additional materials consist of articles, statutes, charts and cases not found in the casebook.

Course Description: This course examines federal and state laws concerning familial relationships (broadly construed) and the policies and principles that undergird them. The court focuses on legal family relationships between adults, specifically: who can get married; the rights, duties, and obligations of marriage; the state's interest in marriage; the dissolution of marriage; the distribution of property upon dissolution; various jurisdictional issues relating to marriage and divorce; and the arrangements between divorced parents regarding custody, support and visitation of children. The course also considers alternatives to marriage. Special attention will be paid to policy-based and theoretical questions about families.

Learning Outcomes: In this class, you will learn the foundations of family law. You will leave with an understanding of how South Carolina courts address the issues of marriage, divorce, child custody and child support. You will also learn how South Carolina law differs from other states. The goal of this class is to provide the foundational family law knowledge necessary for the bar or for a potential career in family law practice. You will learn how to draft basic family law documents, such as prenuptial agreements, learn how to divide property and custody, and how to argue crucial issues of family law and policy.

Assessments: All students are expected to do all the assigned reading for every class, to attend class regularly and to be prepared to participate. Students who miss more than 25% of the class sessions (more than 6) will not be permitted to sit for the exam. The class will use an on-call system based on the seating chart. 3-5 students will be on call each class period. Students on call should be prepared to answer questions and readiness to answer questions will be part of the class participation grade. The remaining part of the class participation will constitute 20% of a student's final grade. The remaining portion of the grade will be based on the final exam. I will discuss the form and mechanics of the final exam in the latter part of the semester.

Reading Pace: Most classes will cover three cases, some will cover fewer and a few will cover four. In order to remain prepared for class, always read three cases ahead of where we stopped in the previous class. This means, if we only cover two cases during a particular class you should read the next new case and reread the two that were not yet covered.
