Learning Outcomes:

The knowledge, skills and values that students are expected to acquire during this course are as follows:

- consideration of the international intellectual property (IP) legal framework;
- examination and analysis of international bodies and treaties which control IP-related interactions between nations;
- some specific focus on the IP laws of key nations worldwide (e.g. EU-UK/Japan/China);
- comparative overview of varying national IP laws; and,
- litigation and enforcement considerations, including IP-specific procedure and legal concepts.
